VISITOR AND CONTRACTOR SITE RULES

ALLERGENS:

The following allergens are handled on harvesting boats and/ or processing environments; please advise your host if you are allergic to any of these substances:

- Molluscs

HYGIENE:

- Jewellery – only plain wedding bands are permitted. Please remove earrings, watches, necklaces, bracelets, tie pins, cuff links and piercings. Please tell your host if you wear SOS jewellery.
- False eyelashes, false fingernails and nail varnish must be removed.
- Perfumes, aftershave or strong smelling cosmetic products are not allowed.
- Smoking – is only permitted at designated smoking area.
- Eating & drinking is prohibited during harvesting and in the processing environment (including sweets or chewing gum).
- Have you handled nuts prior to entering this harvesting boat/ processing environment?
- Any protective clothing provided must be worn at all times.
- Do not handle molluscs unless invited to do so by your host.
- Do not cough or sneeze over the molluscs.
- Do not change any equipment settings unless invited to do so by your host.
- Cuts, grazes or sores must be covered by a suitable waterproof dressing.
- Photographic/ recording equipment may only be used when permission is given by your host.
